



**MEMORANDUM OF UNDERSTANDING
BETWEEN
NATIONAL UNIVERSITY OF MODERN LANGUAGES
AND
PAKISTAN GIRL GUIDES ASSOCIATION**

National University of Modern Languages (NUML), Islamabad, one of the leading universities in Pakistan, is contributing in creating knowledge with a local and global perspective. It is teaching 27 oriental and occidental languages in addition to providing education in five different faculties: Faculty of languages, English Studies, Social Sciences, Management Sciences, Engineering and Computer Sciences. In all these fields, NUML is also committed to play a major role in research, development and community enhancement.

And

Pakistan Girl Guides Association (PGGA), Islamabad, a Body Corporate that is protected and incorporated by Ordinance No. XLIV of 1960 by Government of Pakistan, having its registered office located at [Plot No. 12, Street No. 7, Sector H-9/4, Islamabad]. Pakistan Girl Guides Association (PGGA) started in 1947 in Pakistan & emerged on the World map in 1948 when it became full member of the World Association of Girl Guides and Girl Scouts (WAGGGS). It is a National Movement of empowered girls and young women working as the agents of change to build a better world. PGGA through its seven chapters is operative throughout Pakistan.

NUML and PGGA, hereinafter will be referred as **Parties**, have agreed as follows:

**Article 1
General Principle**

The Parties shall implement the provisions of this MOU in conformity with their organizational laws and other obligations and will play their imperative roles in the promotion of physical and outdoor activities for the upbringing of the students with respect to the exercise of rights that each Party has in the operation and management of the PGGA's project "Stay Safe"

Article 2
Areas of Cooperation

The main areas of mutual cooperation between the Parties within the limits of their responsibility shall be as follows:-

Responsibilities of PGGA:

- a. Identifying groups of girls in higher education institutions desirous of completing their community service component of their degree with PGGA.
- b. Training these groups in the four social service campaigns namely:
 - (i) Assuring personal safety
 - (ii) Preventing substance abuse
 - (iii) Online Security
 - (iv) Emotional Well Being
- c. Facilitating these girls / Students in carrying out these campaigns in other educational institutions.
- d. Record keeping.
- e. Preparing students of Education Department as Guide Leaders in Primary & Secondary educational institutions, thus enabling them to organize Guide Companies in their respective educational institutions, when they start their careers as educators.
- f. The campaigns will be managed by PGGA.

Responsibilities of NUML

- a. Identifying groups of students in all the departments of NUML who are desirous of completing the community service component of their degree under the aegis of PGGA.
- b. Facilitating the above mentioned students in their work with PGGA.
- c. Recognizing the community work with PGGA as valid for the fulfillment of the degree requirement.
- d. Providing a period of time when the campaigns could be prepared and executed.
- e. Providing a location for execution of training.
- f. Facilitating the students if needed, in reaching out to educational institutions where the campaign's service component can be carried out.

Article 3
Legal Liabilities

It is understood that neither party to this MOU is the agent of the other and neither is liable for the wrongful acts or negligence of the other and this will involve no financial/legal liabilities on any party even if it is amended or modified or reviewed at any time through mutual consent of both parties in writing. Standard policies of NUML and PGGA shall be applied for all mutual working relationships.

Article 4
Amendment or Modification

This MOU may be amended or modified at any time through mutual written consent of the Parties. The amendment or modification shall enter into force in the like manner as provided in Article 7 of this MOU.

Article 5
Settlement of Disputes


All differences or disputes arising from or concerning with the application or the interpretation of this MOU shall be amicably settled through mutual consultations and negotiations between the Parties in writing.

Article 6
Non-Financial Obligating Document

This MOU is neither a fiscal nor a financial obligation document. Any endeavor or transfer of anything of value involving reimbursement or contribution of funds between the parties to this MOU will be handled in accordance with applicable laws, regulations and procedures of the parties. Such endeavors will be outlined in separate document that shall be made in writing by representatives of the parties and shall be independently authorized by appropriate statutory authority. This MOU does not provide such authority.

Article 7
Entry into Force, Duration and Termination


This MOU shall enter into force on the date of Signatures and shall remain valid for a term of **FIVE** years. Either party may terminate this MOU by giving a notice of its intention to terminate this MOU six months before the expiration of the original or the renewed period. This MOU can be extended with mutual consent of the parties for an agreed upon duration. The activities undertaken during the validity of this MOU shall




continue to be governed by its provision till their completion, unless the Parties agree otherwise.




